Mae'n bleser gennyf gyflwyno adroddiad blynyddol Ysgol Rhydypennau ar gyfer y flwyddyn 2020/21 ar ran y Corff Llywodraethol. Yn yr adroddiad cewch grynodedb o waith a chyflawniadau'r ysgol yn ystod y flwyddyn aeth heibio, yn ogystal â manylion rhaglenni'r ysgol a threfniadau cwricwlaidd.

Newidiadau i'r Cyfarfod Blynyddol Rhieni/Llywodraethwyr

O ganlyniad i Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013, a ddaeth i rym ar 4 Mai 2013, nid yw'n ofynnol bellach i gorff llywodraethu gynnal cyfarfod blynyddol i rieni.

Y rhieni ydy'r prif ran ddeiliaid yn y gymuned ysgol ac mae ganddyn nhw ddiddordeb clir a chryf yn addysg eu plentyn. Mae'n bwysig felly bod y corff llywodraethu yn ymgysylltu'n weithredol gyda rheini ac yn parhau'n atebol trwy roi gwybodaeth a chyfleoedd iddyn nhw drafod a chael mewnbwn i'r ysgol.

Mae'r Ddeddf Safonau a Threfniadaeth Ysgolion (Cymru) 2013 bellach yn galluogi rhieni disgyblion cofrestredig yn yr ysgol i ofyn am hyd at dri chyfarfod y flwyddyn gyda'r corff llywodraethu trwy gyfrwng deiseb. Darperir crynodeb byr isod.

Rhaid i'r corff llywodraethu gynnal cyfarfod o fewn 25 diwrnod ysgol o dderbyn deisbeb, cyn belled:

1. bod y ddeiseb yn cynnwys llofnodion yr isafswm angenrheidiol o rieni disgyblion cofrestredig

yn yr ysgol, sef yr isaf o'r canlynol:

(a) rheini 10% o ddisgyblion cofrestredig, neu

(b) rheini 30 o ddisgyblion cofrestredig¹.

2. rhaid i'r cyfarfod y mae rhieni wedi gofyn amdano drafod mater yn berthynol i'r ysgol.

1 Wedi'i gyfrifo trwy ddefnyddio nifer y disgyblion cofrestredig yn yr ysgol ar y dyddiad y derbyniwyd y ddeiseb.

3. ni chaiff mwy na thri chyfarfod eu cynnal yn ystod y flwyddyn y derbyniwyd y ddeiseb gyntaf.

4. mae digon o ddyddiau ysgol ar ôl yn y flwyddyn ysgol i gynnal y cyfarfod.

Mae'r cyfarfod yn agored i holl rieni disgyblion cofrestredig yn yr ysgol, y pennaeth ac unrhyw berson arall a wahoddir gan y corff llywodraethu. Cyn gynted ag y mae'n rhesymol ymarferol, rhaid i'r corff llywodraethu hysbysu holl rieni disgyblion cofrestredig yn yr ysgol mewn ysgrifen, beth ydy dyddiad y cyfarfod, a'r mater i'w drafod.

CHANGES TO THE ANNUAL PARENT/GOVERNOR MEETINGS

Section 94 School Standards and Organisation (Wales) Act 2013 (the Act) makes important changes to the previous legislative arrangements in respect of the Annual Parent/Governor Meetings. It provides new arrangements whereby parents can request a meeting with a governing body.

However, the parents will need to satisfy the four (4) statutory requirements when calling a meeting which are as follows:-

- (i) that the parents of 10% of registered pupils, or the parents of 30 registered pupils (whichever is the lower) must sign a petition requesting a meeting;*
- (ii) the meeting must be for the purpose of discussing matters relating to the school;*
- (iii) the maximum number of meetings that parents can request in any school year is three (3);*
- (iv) there must be sufficient school days left in the school year to allow a meeting to be held.*

Further:-

- (a) meetings must be held before the end of a 25 day period;*
- (b) the 25 day period commences the day after receipt of the petition but does not include any day which is not a school day;*
- (c) if another meeting is required to be held as a result of a different petition the 25 day period will not commence until the day after the other meeting has been held;*
- (d) there must be sufficient days left in the school year to allow a meeting to be held before the end of the 25 day period;*
- (e) meetings will be open to all parents of registered pupils at the school, Head and any other person invited by the governing body;*
- (f) notification of meetings to parents must include the date, time and venue of the meeting and the matter or matters to be discussed.*

Governing bodies will need to inform the parents annually of the right to petition a meeting using the powers provided by Section 94

Mae Corff Lawn y Llywodraethwyr yn cwrdd o leiaf unwaith pob tymor. ANGHENION DYSGU YCHWANEGOL / CYNHWYSIANT

Yn Ysgol Rhydypennau, rhoddir cyfle i bob disgybl gyrraedd ei llawn botensial ac i weithio ar lefel sy'n addas ar eu cyfer. Bydd pob disgybl sydd ag anghenion dysgu ychwanegol yn ystod eu cyfnod yn yr ysgol yn derbyn cynllun addysg unigol sy'n amlinellu eu cryfderau a'u gwendidau, a byddwn yn meithrin y rhain. Ein nod ydy sicrhau bod yna ddarpariaeth effeithlon yn ei lle er mwyn cynnal disgyblion yn effeithiol, ac rydyn yn sicrhau bod hawliau pob plentyn wedi'i gyflenwi trwy ddarparu cefnogaeth ychwanegol gan yr athro dosbarth, cynorthwywyr addysgu ac asiantaethau allanol. Rydym yn cyfathrebu'n agos gyda rhieni disgyblion sydd ag ADY, gan ddarparu gwybodaeth am gynnydd disgyblion yn erbyn eu targedau. Gwneir hyn trwy gyfarfodydd nosweithiau rhieni, trwy gynnal Adolygiad Blynyddol neu'r ddau. Adolygir y polisi ADY bob dwy flynedd, ac fe nodir unrhyw newidiadau i'r ddeddfwriaeth yma. Rydym yn archwilio cofrestr ADY yr ysgol yn nhymor yr hydref, ac mae hyn ynghyd a niferoedd disgyblion yn pennu darpariaeth gyllidol i'r flwyddyn sydd ar ddod.

Mae athrawon dosbarth yn gwahaniaethu gwaith disgyblion yn unol â gofynion y cwricwlwm. Mr Melfyn Jones ydy'r Cydlynnydd Anghenion Dysgu Ychwanegol (SENCo) a Mr Rhodri Morgan ydy'r Llywodraethwr a chyfrifoldeb ADY.

ADDITIONAL LEARNING NEEDS / INCLUSION

At Ysgol Rhydypennau, every child is given the opportunity to achieve to the best of his / her ability and to work to the level suited to them. A child experiencing additional learning needs (ALN) at any stage in their school life, will have both their strengths and weaknesses recognised and nurtured. It is our aim that every child will work to fulfil his/her own potential and it is the right of every child experiencing ALN at any stage in their school career to be offered support either from the class teacher or teaching assistants or outside agencies. The parents of any child experiencing ALN or emotional or behavioural difficulties is informed of support offered and progress made, this may be at an Annual Review or Parents' Evening or both. The School's ALN Policy is currently reviewed as part of a two yearly cycle and any changes to legislation are noted and included. Currently the School's additional learning needs register is audited in the Autumn term and this along with pupil numbers and Local Authority formula dictates the financial provision for the forthcoming year.

Class teachers differentiate work accordingly within the curriculum for the children in their classes. The Special Educational Needs Co-ordinator's (SENCO) role is undertaken by Mr Melfyn Jones and Mr Rhodri Morgan is the Governor with special responsibility for ALN.

ADEILAD YR YSGOL / SCHOOL BUILDINGS

Yn ystod y flwyddyn 2020-21, cynhaliwyd y gwelliannau isod; / During the school year 2020 / 2021, the following improvement projects were undertaken;

- Drysau tân mewnol newydd wedi'i osod / New internal fire doors installed*
- Canopi newydd wedi'i godi ar gyfer y cyfnod Sylfaen / New external canopy erected for the foundation phase*
- Gwaith cynnal a chadw yn nhoiledau ar draws yr ysgol / Maintenance work carried out in toilet blocks across the school*
- Nenfwd newydd wedi'i osod yn neuadd yr ysgol / New ceiling installed in school hall*
- Llawr Newydd wedi'i osod yn nosbarthiadau Bl.1 a Bl.2 / New flooring installed in Yr. 1 and 2 classrooms during.*

GWEITHREDOEDD YN YMWNEUD A BWYTA AC YFED YN IACH / ACTION TAKEN TO PROMOTE HEALTHY EATING AND DRINKING

Mae Ysgol Rhydypennau yn rhan o gynllun 'Ysgolion Iach Ceredigion' ac yn manteisio ar bob cyfle i sicrhau bod disgyblion yn dysgu pwysigrwydd y cynllun mewn modd hwylus ac ymarferol. O fewn y cynllun, mae ysgolion yn targedu mentrau gwahanol, yn eu tro, ac yn creu cynllun er mwyn datblygu'r rhain ar lefel ysgol gyfan; gyda maeth yn flaenoriaeth i'r asesiad. Rydym yn disgwyl archwiliad yn unol â'r cynllun yn ystod 2020/21.

Ysgol Rhydypennau is part of Ceredigion's 'Health Promoting Schools' initiative and makes every effort to ensure that pupils learn these key life skills in a fun and practical way. Within the Healthy School initiative themes are targeted within the school and an action plan created to develop aspects further on a whole school level: nutrition being one of the main aspects. We are due to be assessed to receive our next accreditation during 2020/21.
